This Membership Agreement between Member, listed above, and Glendale Grace Firearms & Training, LLC (the "Gun Club") is a life-time membership, so long as the member pays dues on an annual basis in accordance with the payment plan checked below and so long as the membership has not been terminated in accordance with the Gun Club's Rules and Regulations. A late fee of \$25 will be applied for any payments after the fifth of the month. A charge of \$25 will be made for any checks returned due to insufficient funds. The Gun Club may change the dues to be paid under this Agreement by posting notice of such change in the Gun Club at least 90 days in advance of such change. All first-year members will be locked into their membership dues for two years so long as the membership does not laps. All payments to the Gun Club are final and non-refundable and can be made by cash, credit, debit, or local check.

Single Membership Dues:

Annual Payments: A payment in the amount of \$300.00 plus tax, plus a \$50 Safety Orientation fee must accompany the application. (This will not go up for two years for charter members.) Charter members will always get the lowest price we can offer after the two years is over. (See below for possible discounts)

Family Membership Dues:

Annual Payments: A payment in the amount of \$300.00 plus tax for the first member, \$250.00 plus tax each additional adult member over 18 (membership for children 13-21 are \$50 plus tax a year with parent's membership must live at home. Children 12 and under are free with parent's membership. All members under 18 must be accompanied by their parent when on site.), and a \$50 Safety Orientation fee (All family must attend--adult or child) must accompany the application. All family members must live in the same household. (This will not go up for two years for charter members.) Charter members will always get the lowest price we can offer after the two years is over. (See below for possible discounts) If your child is in collage and still uses your address, we will leave them at the \$50 rate till they graduate or are no longer in school.

LEO Group Membership Dues:

Annual Payments: A payment in the amount of \$1000.00 plus tax for 10 members must accompany the application. The \$50 Safety Orientation fee is waived for active LEOs. Group members may come out as a group or by themselves once membership is paid. For additional members over 10 the price will be \$100 per member plus tax. Must have at least 10 members to get this plan. (This must be done at the office of GGF. No online purchase for this)

Corporate/Group Membership Dues:

Annual Payments: A payment in the amount of \$1500.00 for 10 members plus tax must accompany the application. Each member must pay a \$25 Safety Orientation fee. Group members may come out as a group or by themselves once membership is paid. For any additional members over 10, their membership will be \$150 each plus tax, plus the \$25 Safety Orientation fee. (The Safety Orientation fee may be discounted if the group member has taken one or our classes, or is a Reserve Law Enforcement Officer). This must be done in the GGF Office no online purchases for this option.

Range Fees:

There will be a \$10.00 range fee for members for lead cleanup.

Guest Fees:

Day Pass for guests: \$25.00 range fee and \$1.00 for any additional targets if needed. One target comes with the range fee. You can only bring a guest twice a year.

Only check one discount. We do not allow for stacked discounts.

Legal Stuff:

1. You understand that the above referenced fees and dues are specific to you, and do not necessarily represent other members' dues and fees, and that the Gun Club may change the yearly dues and other fees, with notice, as provided above.
2. For a Family Membership, your spouse and children under the age of 18 as well as children who are attending college up to age 23 (must provide current student ID) will be considered a member and not required to pay a guest fee so long as they are part of your family plan. Each spouse will serve as a representative who, upon completing this Membership Agreement, Background Check, Liability Release, and Member Orientation that is accepted by the Gun Club, shall have the rights and privileges of a member. A Family Membership annual dues are \$300.00 plus tax for the first member + \$250.00 plus tax per family member 18 and over living in your home. Children 13-18 are \$50 plus tax a year, and all children under 12 are free. Anyone under 18 must be accompanied by a parent. (This fee schedule will not go up for two years for first year charter members but may change as the Club grows after the two years is over.) Parents are solely responsible for their children's safety and behavior. Out of control children can have you removed from the property and

membership canceled with no refund.

3. For corporate/group members, you shall be entitled to (10+) total members who work for your business. Each member will serve as a representative who, upon completing a separate Membership Agreement, Background Check, Liability Release, and Member Orientation that is accepted by the Gun Club, shall have the rights and privileges of a member. Multiple employees may be appointed by payment of the Dues and other relevant charges. Corporate/Group Membership yearly dues are \$1500.00 plus tax for 10 members, and will be \$150.00 plus tax for each members over 10. All members in a corporate membership must be over 21. Breaking range safety rules can get you removed from the property and membership canceled with no refund. This option must be completed at the GGF Offices.
4. You agree to obey all Gun Club Rules, as amended from time to time, for the use of the Gun Club facilities and the Gun Club reserves the right to revoke your membership if you fail to keep and obey any of the Rules, or if you violate the Gun Club's Firearms Safety Rules and Regulations, or if you cause a nuisance, disturbance of the Club Facilities, or for any other reason deemed necessary by Gun Club management. In the event that your membership is revoked for any of the foregoing reasons, no fees, dues or other charges shall be refunded.
5. You agree that this Membership Agreement is not assignable or transferrable and no rights or privileges granted by this membership can be transferred or assigned.
6. You confirm that you are familiar with shooting ranges and the safe discharge of firearms, and you agree that all the use of the Gun Club's premises and facilities shall be at your sole risk.
7. YOU AGREE THAT YOU UNDERSTAND THE USE OF THE GUN CLUB FACILITIES AND YOUR PROXIMITY TO THE DISCHARGE OF FIREARMS NECESSARILY INVOLVES CERTAIN DANGERS AND RISKS, AND THE GUN CLUB SHALL NOT BE LIABLE TO YOU, YOUR FAMILY OR GUEST(S) FOR ANY CLAIMS, DEMANDS, INJURIES, DAMAGES, OR ACTIONS ARISING DUE TO INJURY TO YOUR PERSON OR PROPERTY ARISING OUT OF OR IN CONNECTION WITH YOUR USE OF THE SERVICES AND FACILITIES OF THE GUN CLUB.
8. You agree that the Gun Club is not responsible for the actions of any of its members or guests. If you bring any personal property onto the premises of the Gun Club premises or parking area, you take such action at your own risk. You understand that the Gun Club is not responsible in any way for damage to or loss of any personal property that you bring onto the Gun Club premises or parking areas, including but not limited to, losses due to theft, damage, or car accident. You agree to hold the Gun Club, its successors, assigns, owners, officers, managers, employees, and agents harmless from all claims which may be brought against them by you or on your behalf, by your family, and your executors, administrators, and personal representatives for any such injuries or claims aforesaid and you for yourself and on behalf of your family, executors, administrators, and personal representatives do hereby forever release and discharge the Gun Club, its successors, assigns, owners, officers, directors, employees, and agents from all claims, demands, injuries, damages, actions, losses and expenses. This section will survive any cancellation, expiration or termination of this Agreement. You agree to pay for all breakage or damage to Gun Club property caused by you, your family members and your guests.
9. You confirm and understand that being a member of Glenndale Grace Firearms & Training, LLC does not mean that you own any membership interest, stock, ownership interest or any other form of equity in Glenndale Grace Firearms & Training, LLC or any of the real estate upon which the Gun Club's facilities are located. The use of the term "Gun Club" and "Gun Club Member" is intended merely to represent a means of structuring various privileges granted by Glenndale Grace Firearms & Training, LLC to use its facilities. No part of the earnings of Glenndale Grace Firearms & Training, LLC shall inure to your benefit
10. You agree that you will always check in with the office before and after using the Ranges or any of Glenndale Grace Firearms and Training facilities. This is so we know how many people are on the property at any given time in case of emergency.
11. Dues bills are typically mailed or emailed to you two months before due date. Dues payments must be received by the last day of the month of due date to avoid late fees. Dues received on or after the due date are subject to a \$25.00 late fee. Dues received after the 10th of the following month will no longer be a charter member and will start as a new member under whatever dues apply at that time. If it goes more than 6 months you

will need to re-apply as a new member and will be subject to the Safety Orientation fee. All charter members will be locked into their membership dues for two years when paid on time

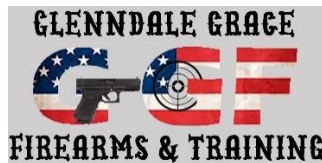

Waiver of Liability

1. I, the undersigned, on behalf of myself, and my heirs and assigns, hereby acknowledge that I have voluntarily applied to enter on to and to engage in and/or observe shooting and other activities at the Glendale Grace Firearms & Training, LLC Gun Range ("GGF"). These activities include, but are not limited to, the use and discharge of firearms provided either by me or by GGF, and the services and training by employees or contractors of GGF.
2. I acknowledge that access to the facilities of GGF has value to me and to others, and by granting me access GGF may of necessity be required to deny access to another qualified person. As consideration for being granted such access I agree to the terms and contents of this Waiver of Liability and Assumption of Risk and agree to abide by any other rules and conditions for such access including adhering to the Four Fundamental Rules of Firearms Safety of which by signing this document I declare and state that I am well-informed and fully knowledgeable.
3. I acknowledge and understand that shooting activities are inherently hazardous and may involve both known and unanticipated risks which could result in damage or destruction of property and physical or emotional injury, including paralysis or death, of myself or of other persons. These risks include but are not limited to being shot or shooting myself or others; partial or total loss of eyesight or hearing; inhalation or other harmful contact with lead or other contaminants; and being struck by flying or falling objects. I further understand that discharging firearms and using ammunition pose potential inherent dangers that no amount of care, instruction, or expertise can eliminate.
4. I further acknowledge and understand that GGF is an outdoor shooting facility which utilizes concrete, hay and dirt berms, which are designed to contain and decelerate discharged projectiles; I understand that these devices do not, in every possible instance, properly contain projectiles, bullets or bullet fragments and can potentially allow ricochets which could potentially cause serious personal injury or death.
5. I further acknowledge and understand that GGF is an outdoor shooting facility open to members and their visitors, and the publication of the GGF Code of Conduct/Range Safety Rules, and the provision of staff and range officers in no way constitutes a guaranty or warranty of any kind. GGF shall not be liable as to the conduct of any person on or off the premises of GGF or the compliance or failure to comply with any rules or codes of conduct by any person.
6. I further acknowledge and understand that GGF makes no warranty as to the design, manufacture, condition or fitness for any particular purpose of any GGF facilities or equipment, including, but not limited to firearms, ammunition, eye/hearing protection, and first-aid supplies.
7. Unless I specifically inform GGF Staff otherwise at Range check-in, I represent that I am experienced and skilled in the proper handling, loading, use, and discharge of all firearms and ammunition I intend to use at the GGF facility and am familiar and well versed in the fundamental rules of firearms handling and safety. I understand that GGF is specifically relying on the truth of my representations concerning my experience with firearms and knowledge of safety rules in permitting me to make use of its facilities.
8. I have never been convicted of a felony or a crime of domestic violence in any of the 50 United States, the United States, or territories of the United States. I understand that Oklahoma and/or Federal law prohibits any person convicted of a felony or a crime of domestic violence to be present in any environment where firearms are present.

9. I am not an abuser of alcohol nor am I an illegal user of any dangerous drug or narcotic.
10. I will not come on the property of GGF if I have used, within the last 24 hours, alcohol, marijuana, or any potentially impairing drug -- prescribed or over the counter.

11. AS LAWFUL CONSIDERATION FOR BEING PERMITTED BY GLENNDALE GRACE FIREARMS & TRAINING, LLC, GUN RANGE TO ENTER AND USE ITS FACILITIES OR EQUIPMENT AND TO ENGAGE IN OR OBSERVE SHOOTING AND OTHER ACTIVITIES AS A PARTICIPANT, I AGREE AS FOLLOWS:

a. I agree to assume full responsibility for any and all risks, injuries, or damages, known or unknown, of whatsoever any kind and nature, which I might incur as a result of entering onto and using the GGF' facilities or equipment and in engaging in or observing shooting and other activities at the RANGE, including death.

b. I agree to abide by GGF' Code of Conduct / Range Safety Rules now and as modified in the future.

c. I knowingly, voluntarily and expressly waive any and all claims I, my next of kin, heirs, guardians, representatives, assigns or any other person claiming under me completely and without reservation that I may have against GGF, its agents, officers, members, employees, instructors, volunteers, or representatives from any and all injuries or damages that I may sustain as a result of me entering onto and using GGF' facilities or equipment, or engaging in or observing shooting range activities, including death. Also, I, my next of kin, heirs, guardians, representatives, assigns or any other person claiming under me, forever release, waive, discharge and covenant not to sue GGF, its agents, officers, members, employees, instructors, volunteers, or representatives for any personal injury, death, disability, property damage, property theft or acts and/or omissions of whatsoever kind and nature including, but not limited to, those caused by its negligence or other acts including, but not limited to, those acts and/or omissions of other participants or persons at the GGF' facilities.

d. I further acknowledge and agree that it is my understanding and intent that this Agreement, and any Exhibits, thereto and any signed written amendments or modifications to it, including but not limited to the choice of law and venue and binding arbitration clauses in the Agreement are a fundamental part of this document and are incorporated into this document as if fully written here again.

e. I further acknowledge and agree that it is my understanding and intent that the Agreement, the Exhibits, thereto and any signed written amendments or modifications to it shall remain in full force and effect from the date of execution and ever after shall be applicable to each and every occasion that I enter onto and use GGF' facilities or equipment or engage in or observe shooting and other activities at GGF.

f. I have carefully read this "Waiver of Liability and Assumption of Risk" and fully know its contents. I acknowledge that no other inducement, assurance or guarantee has been made to me in consideration of my signing this Waiver and that I sign voluntarily and of my own free will.

g. I further acknowledge and agree that this Waiver may be amended or modified only by a writing signed by me and by an authorized agent of the GGF.

RULES AND REGULATIONS:

SAFETY RULES:

- Treat all firearms as if they were loaded.
 - Be sure of your target and what's beyond it.
 - Keep your finger off the trigger until ready to fire.
 - Always wear hearing and eye protection.
- *Range Rules, Regulations & Waiver of Liability and Claims must be signed and followed by all who enter the range to shoot.*

1. GUNS & TARGETS BROUGHT INTO THE RANGE:

All firearms brought into the range must be completely UNLOADED. All targets must meet the minimum range requirements and be approved at the office

2. RANGE OFFICER:

- a. The Range Officer if on duty is in direct charge of the range at all times.
- b. The Range Officer will ban from the range any person handling a firearm in an unsafe or careless manner. The Range Officer may also void this person's membership without refund.

3. Firing Lin Procedure:

- a. Only one loaded gun at a time. No other gun handling behind the firing line.
- b. Make sure your ear and eye protection is on before entering the range area. Take position at the lane assigned to you. Do not change lanes.
- c. The MUZZLE MUST BE POINTED DOWN RANGE AT ALL TIMES.
- d. No rapid firing is allowed.. Rifle calibers only. Unless LEO Training.
- e. Targets MUST be set at a full distance before shooting. Rifle calibers only.
- f. Shooter must load and unload their own firearms. If a mechanical malfunction occurs, check in with the Range Officer, or call the office and someone will come help you if you need it. DO NOT leave the range firing line with the firearm.
- g. Keep your finger off the trigger until on target.
- h. When leaving the firing line temporarily, lay the firearm with the muzzle down range and the action open
- i. When you are finished and want to leave, unload firearm(s) with the action opened, unless it is cased.
- j. Cease firing means... STOP shooting.
- K. DO NOT remove jammed or malfunctioning firearms away from the lane; contact the Range Officer or call the office for help immediately!

4. VANDALISM:

Any person seen firing at light, baffles, carriers, trashcans, unauthorized targets or any other range property or equipment will have their membership canceled and will be reported to the proper authorities for appropriate action. Firing at boxes, cups, or other objects is prohibited. Only targets authorized by the Range Officer, or office will be permitted. You will be held accountable and may have to pay for any damage you cause.

5. FIREARMS PERMITTED:

- a. Centerfire rifles on the rifle range, or 50-yard range ONLY.
- b. No tracer rounds or incinerates on the range.
- c. Full automatic firearms are allowed if license is verified.
- d. Black powder muzzle loading firearms are permitted on the Rifle Range.
- e. Shotguns are allowed at the discretion of the Range Officer.
- f. Any firearms not mentioned here, check with the Range Officer before using them on the range.
- g. No horse play EVER!
- h. Never shoot into hay bales.

6. AMMUNITION PERMITTED:

- a. Standard commercial and reloaded ammunition is permitted, at your own risk.
- b. Any type ammunition designed for penetration metal is not permitted.
- c. NO STEEL JACKETED, STEEL SHOT OR STEEL CORE BULLETS permitted.
- d. NO TRACER, INCENDIARY, GAS OR EXPLOSIVE AMMUNITION permitted.
- e. No shot shells larger than 7½ on the trap range. IE: 7½ and up. All numbers lower are larger shot, 6 is bigger than 7.
- f. Slugs only on rifle range.

7. FIRING LINE OCCUPANTS:

- a. All persons using the facilities will be of good character. Appropriate dress is required at all times. Please remember we are a family oriented facility. (We have the right to refuse service to anyone. Anyone who has the smell of marijuana, or has alcohol on their breath, or who appears impaired will be invited to leave the facility).
- b. All persons utilizing the range are required to receive, understand and sign the rules, regulations, and disclaimer notice.
- c. For handguns, a responsible adult must accompany person under twenty-one (21) years of age. This adult shall act as a coach and MUST remain with the minor at all times while the minor is utilizing the range.
- d. NO FOOD, DRINK, CHEWING TOBACCO, SNUFF, OR SMOKING ON THE RANGE. This can be done at your car.
- e. Only one shooter or coach permitted per lane, only one un-cased firearm permitted at the firing line.
- f. Persons not shooting or coaching are not permitted on the range. (you must stay outside the wall berms if only observing).
- g. No one permitted forward of the firing line until all firearms are unloaded and benched.
- h. Any equipment or other personal items in the shooting any left unattended is at the owner's risk.

8. BRASS RETRIEVAL:

- a. All range brass is asked to be cleaned up once the range is safe.
- b. DO NOT go down the range to retrieve your brass if others shooters are on the range.

9. EYE PROTECTION:

All persons on the range MUST wear eye protection. It is available for purchase if you do not bring your own.

10. EAR PROTECTION:

- a. All persons on the range MUST wear ear protection. It is available for purchase if you do not bring your own.
- b. A billed hat is encouraged as well.

By signing below, I agree I have read all of the safety rules and regulations of the range, I furthermore acknowledge I will use Glenndale Grace Firearms & Training Range at my own risk.
